



2019 Fees and Donations

You will be aware that there are a number of different fees and donations each year for students at all integrated schools. Fees are compulsory and each family undertakes to pay these when they enrol their child at St. Mary's. Donations are not compulsory, however, they enable us to offer a broad range of activities at St. Mary's. These fees and donations are as follows for 2019:

This contribution provides the main source of funding for all services provided to St. John's School by the Catholic Education Services Board. No contributions are made by the Government for these services. The Catholic Education Services Board assists schools to provide a Catholic education for your child through the preservation and enhancement of the Catholic Special Character in our schools. The Special Character donation is tax deductible. • St. Mary's Building Fund - \$50 per term for the first child, \$25 per term for the second child - this fund supports the school to make improvements to school property (does not pay for the new building). The board is currently developing a new property enhancement plan and this fund will enable us to carry out this work. • Parent Contribution Donation \$70 per term for the first and second child and then \$35 per term for the third child. This donation provides funds, additional to Government Grants, for the running of the School and supports us in the running of the school, ensuring we can provide a wide range of educational experiences for our students • Activity donation \$50 per annum per child supports us in running Education Outside of the Classroom experiences e.g. class/ hub trips
